As we have been talking about spiritual warfare, this month we are going to continue our examination of some of the **Judicial Instruments** as well as the **Judicial Processes** that the Lord Jesus Christ, the Lord of Hosts, and the Holy Ghost employ when they are judging matters pertaining to humankind and the Courts of the Universe.

Since we are talking about the courts of the universe, I will take this time to let you know that what I am posting is what I am living through. As most of you know already, the devil tried to take me out by giving me pneumonia that shredded my heart, causing me to have to be put in the hospital for 11 days. Understand that I have been filing many cases against that fool devil for a while now, using [complaints](#) and [petitions](#), asking the Lord to adjudicate these legal actions against the devil so he will leave me alone.

The other day, in my quiet time with the Lord, I was informed that I was being counter-sued by the devil. It seems that all of the [complaints](#) and [petitions](#) that I have filed that he was ignoring is now being enforced by the Lord of Hosts, and the devil is getting pressure to get these complaints and petitions resolved.

In most cases, the devil will not bother with a counter-complaint because most people will not be persistent enough to file complaints in the first place. **Well, I was one of the exceptions, and I am a royal pain in the devils behind. I was informed that I needed to prepare for a [hearing](#) where I was being accused of persecuting the devil.**

Me persecuting the devil. Imagine that.

At first, I did not understand why I had to argue a case of accusation. I didn't accuse anyone of anything! Then I realized – **[accusations are counter-complaints to try and counter the avalanche of complaints I filed against the devil.](#)**

Now the Bible tells us that the devil accuses us in front of the Lord of Hosts all day long, and those accusations are legal actions that the devil files against YOU

when you sin. You have learned that you can remove the legal rights the devil has on you when you sin; the devil cannot lord your sin over you anymore if you are granted repentance by the Lord Jesus Christ, the Holy Ghost, or the Lord of Hosts (any one of them can grant you repentance if you are a disciple or a follower of Christ in good stand with Jesus). You, as a human, have the right to file legal actions against the devil, and most people don't because they are ignorant of the fact that they can. In my case, I have taken full advantage of my rights and I have been blasting that fool devil for YEARS with legal actions against him.

The cost of doing that has been high, but I can see a good result. One of the results is that I have good standing in the court, and that if I bring a case against the devil, that case will be heard almost immediately. I have had to make sure my robe was clean to maintain that standing, and you can see what I am talking about in scripture here:

Zechariah 3:3-4 - Now Joshua was clothed with filthy garments, and stood before the angel. And he answered and spake unto those that stood before him, saying, Take away the filthy garments from him. And unto him he said, Behold, I have caused thine iniquity to pass from thee, and I will clothe thee with change of raiment.

Now understand that if I allow my robe to be dirty (that means if I sin), I lose my standing in the courts of the Universe and I am not allowed back into the court until my robe has been cleaned. The devil has tried to get me back in sin so I cannot continue to file legal actions against him, so this is an ongoing struggle that I am going through.

The good news is that when I do bring cases to the court, we can see the devil back down almost immediately. **I actually enjoy being a royal pain in the behind of the devil, as the devil and I have unfinished business (yes, its personal).** Like President Trump is doing going after the Deep State, I have made it my business to go after the devil to make him pay for putting me in bondage for over 30 years. **It has taken me 10 years to get rid of the bad habits, the foul appetites, and the coarse language that I would normally use to deal with situations.** With the nature change that the Holy Ghost put in me (are you listening, Once saved, always saved people?). I don't sin because I do

not WANT to sin. My nature has changed, and I want to follow Jesus in all that I do.

I get very annoyed with the church these days, especially the churches in Canada that are being persecuted, and you can see the article I wrote [here](#). I was like “**why doesn’t the church rise up and pull down the evil principality that is over their land as it tells us in Ephesian 6?**” Jesus had to check me and tell me that I cannot fight the battle of the people being persecuted for them; they have to fight their own battles and get their churches back by consulting with the Lord Jesus Christ PERSONALLY for guidance and preparation.

- What I CAN do is file complaints and petitions on behalf of the churches being persecuted in Canada, and we are going to spend time with an article on how you can help your brethren by praying and filing cases on their behalf if they are ignorant or unable to do that on their own. Prayers like these are warfare prayers, and it is not a cursory “**we are going to pray for you, brother**” prayers that do nothing.
- What I CAN do is show you what Jesus showed me about persecution and how to eradicate it and then the people who are being persecuted can then talk with Jesus to build the weapons and prayers they will need to pull that principality down.
- What I CAN do is show you how you can intercede using your prayers and build those prayers so you are bombarding the courts of the universe every second of the day until something changes that will stop the prayers and drive off the devil in his high heels.

We are one Body, correct?

In Canada right now, it seems that someone is praying correctly because the Provincial Government has announced that they are going to give the GraceLife Church building back to the pastor and the congregation they took it from (check out the Rebel News article [here](#)). This is a MAJOR victory, and it is my fervent hope that these churches will begin to prepare their congregants for more warfare

because **the devil and the evil principalities that he rules over will not stop picking on Christians until they MAKE the devil stop.**

As a side note, the Health minister of Alberta, Tyler Shandro, who authored the public health mandates and authorized the seizing of the Christian churches in Alberta, is being publicly shamed with a mobile jumbotron as you can see in the article from Rebel News [here](#). By praying in this manner, I am opening multiple cases against the devil every second, and **I have also asked via a petition that each and every complaint must be adjudicated separately.** I have been granted that right as my petition has been accepted and a **decree** has been handed down that the devil has to answer each and every complaint I have made against him because the Lord of Hosts has ordered this to be done.

Well, the devil is not too happy with me right now because now he has to actually do some work for once and sit down and deal with all of the complaints I have filed and follow the directives of all of the decrees that have been given to me in my favour. I do expect that the devil will retaliate at some point, but for the next few months, he is going to be busy giving me my **recompenses** as ordered by the Lord of Hosts.

That, my friends, is how you stand against the devil as **James 4:7** asks us to.
