This month, we are going to explore alternative means to get justice in our lives. As you already know and can see in our posts, there is tyranny that is being foisted upon the people of the world, and it seems like the EVIL has the upper hand. Everywhere you look, you see people who are “complying” with the ridiculous mandates that the health departments are shoving down our throats so they are not fined or incarcerated (which are illegal, by the way).

In other words – they go along to get along, thinking that compliance will bring back “normalcy”.

There is no stand against this tyranny because today's "Christian" has been **pussified** (that's right, I said it) and they are expecting that Jesus will stand in and fight for them and they will not have to go through any hardship. People are AFRAID and they are relying on the Lord Jesus Christ to “rapture” them out of the tyranny that has befallen all of us in the world today.

We are going to discuss how we – the average person who is a real disciple or follower of Christ – can get the justice that we need to push back against the tyranny that is being forced down our throats.

If you look at what goes on in the Bible, you will see that everything – and I mean everything – that is done has a legal basis. In short, that means the devil CANNOT vex you without the permission of the Lord of Hosts, Jesus' Father. The devil, if he is vexing you does so LEGALLY, and this is the focus of our postings this month.

A few months ago, I posted an article name “**The devil is a legalist**”. In this article, **you can see that the devil will only be able to steal, kill and destroy when he has the LEGAL right to do so.** Take a moment to see where people are giving the devil a legal right to vex them in the article **here**.

Did you know that when you ask Jesus to be the Lord of your life, you are entering into a LEGAL agreement (commonly known as a covenant) with the Lord Jesus Christ so you can be saved? If Jesus agrees with you and accepts you as a disciple or a follower of Christ, He confirms the acceptance of you being a disciple or a follower of Christ by sending the Holy Ghost. I cover this LEGAL transaction with the Lord Jesus Christ **here** and you can see all of

the steps the Lord Jesus Christ takes to make disciples/followers **here**. Now you can understand why when you break a covenant, the penalty of breaking that covenant is DEATH, as you can see in our definition **here**. Many people break their covenant with the Lord Jesus Christ when they do NOT hold up their end of the agreement to be "Saved".

When I was writing the “**Sodomite Spirit**” series (Which you can see **here**), **I made a point of showing you how the Sodomite Spirit uses LEGAL means to enslave those who are watching porn**. Watching porn, which highlight **sodomite behaviours**, gives the devil the LEGAL RIGHT to not only enslave a person, but to afflict them with **fetishes** and **demonic influence/possession**. Demons now have the LEGAL RIGHT to be in a person because the devil will permit demons to inhabit that person if a person is enslaved by porn.

So where is the Lord Jesus Christ when people are watching porn?

He is watching and waiting for those people to reach out to Him so they can use His authority to LEGALLY prevent the devil from enslaving them. Unfortunately, over 90% of the people in the world today are IGNORANT of the legal aspects of being a disciple or a follower of Christ, and are foolishly following church doctrine that is leading people away from Christ.

We are going to take some time to analyze the situation that is going on in **Alberta, Canada**, where a church has been shut down by the **Alberta Health Services (AHS)** for not adhering to COVID-19 mandates. We can see the epic struggle in real time – the devil is flexing, shutting down the church, and he is daring the church people to try and reopen the church.

Here is the rub – **the devil got the authority to shut down the church, and he knows that the people going to that church are ill-prepared to fight him**. This is why when others came to Alberta to tear down the fence, the people of that church were powerless to help them and reopen the church. Some of the Canadian neighbours of these people sided with the RCMP to put the fence back up because they are SCARED and they did not want any trouble.

Here we see that there is an evil principality over Alberta that is flexing. This also means that the devil has gotten the LEGAL RIGHT to do what he is doing, and the church that is shut down will need to get the authority and the LEGAL RIGHT to tear down that principality so they can worship Christ in peace in that church.

We will discuss in detail how that church should regroup and fight by filing **complaints** and **petitions** with the Lord Jesus Christ to get Him to issue **decrees** to free that church. We will also show that Jesus is not only our Lord and Saviour, He is a JUDGE, and His decrees are followed by the devil because Jesus has more authority than the devil does.

What is NOT being taught in the churches today is how we can use Jesus' authority to overcome the devil and take ground from that fool. Churches today are prisons where people congregate to just sit there and let the devil slap them around and they do NOTHING to counter what the devil does. I cover that fact in a video, which you can see **here**. I also cover how people and households need to be in order so they CAN be helped. I cover authority **here**, **here** and **here**. Order is covered **here** and **here**.

As you already know, I am neck deep in this fight, and the devil has already tried to take me out by shredding my heart (you can see the sordid detail **here**). I can now appreciate what the Lord has done because He knows that I will NOT shut up about what happened to me and how He stepped in and prevented the devil from killing me.

So why am I not dead right now?

It is because when I was healthy, I consciously sought after Jesus and asked Him how I can counter that fool devil. I wanted to know how prayers were processed (which you can see in an article I posted **here**) and **the Lord of Hosts prevented the devil from killing me because I was actively resisting the devil with my complaints and petitions.** Jesus taught me how to file complaints, how to file petitions, how to get recompenses, and how to use the courts of the Universe to counter the stupid crap the devil pulls. I have highlighted the concepts that the Lord showed me so you can find out for yourself what YOU can do to use these tools to push back against the devil.

I was working on contract at a job that was supposed to last 18 months. The people I was working for informed me in month 9 that they ran out of funding and they were letting me go. Since I was in the Lord of Hosts' **Book of Households**, the Lord of Hosts stood for me and got me into another department – at the same company – without me missing a paycheque (I ended the previous contract on a Friday, and the Lord had me in a new contract on the following Monday. This is a common tactic the devil uses to enslave people, as you can see **here** and **here**).

The devil decided to pull the financial rug out from under me, and because I was in order and in the Book of Households, the devil had NO LEGAL RIGHT to steal my resources. The devil had NO LEGAL RIGHT to interrupt my resource flow for my household or family, and that was the lesson – get the decrees from the Godhead to keep the devil at bay. So, the devil decided to kill me because I trumped his moves to make me subjected to him. You can find out more about this situation in the video I made about it **here**. The video is 24 minutes long, but it is worth your watching it.

Here is the point – **If that church body in Alberta was filing complaints with the Lord Jesus Christ, the Lord of Hosts, and/or the Holy Ghost against the lockdown by the devil, they could have gotten one of the Godhead to issue decrees that would have removed the LEGAL RIGHT the devil had over that church and torn down the principality that is now controlling that church.** The pastor of that church is on the right track, as he stood up and went to a maximum security jail for 35 days for disobeying the health services order, but they didn't go far enough. The associate pastor is to be commended, as he stood in when the head pastor was incarcerated.

If you look at all of the battles in the Bible, the Lord had the Children of Israel WAIT before they went into battle, and it was during that waiting period is when the Lord or Hosts set the LEGAL groundwork BEFORE the battle so the Israelites would prevail when they were in battle. This is something that is not shown to most "Christians", as they are eager to go into battle unprepared and NOT LEGALLY ready. As you can see, **these same "warriors of Christ" are getting their behinds handed to them because they are NOT consulting with the Lord Jesus Christ BEFORE they go out to face off against the devil.**

So, I am going to point out what the church members could have done and what they should do to get their church back. The devil is flexing with 200 RCMP officers in riot gear to keep that ground they got shutting down the church. The ONLY way that church will be opened again would be for them to seek out the Lord Jesus Christ to get HIS authority to break the hold that evil principality has on that church.

The devil wants to make sure you are ignorant of the courts of the Universe because he is using the courts of the universe to subjugate YOU using legal means. Every time the devil accuses you of a sin, that is a “case” the devil is filing against YOU in the courts of the Universe (you can see what I mean **here**, **here** and **here**). If you do not answer or respond, the devil will win his “case” against YOU by default LEGALLY. His recompense is always the same – the devil wants YOU – your soul – as a recompense for his trouble.

This is why **Once Saved, Always Saved** is a fallacy and from the pit of hell. If you think you have eternal security, are you doing to do anything to fight the devil who is building a case against YOU for every sin that you have committed? If you don’t use **repentance** as a tool to remove the LEGAL RIGHT the devil has over you when you do sin, how are you going to counter the devil when you are judged? How are you going to get repentance of your sins from the Lord Jesus Christ when you don’t know Him personally?

Do you REALLY think that Jesus, as a righteous judge, is not going to take into account the “cases” the devil has against you when you are judged? How many people are in hell TODAY because they NEVER resisted the devil as Jesus commanded them to do?

As for me – I have MILLIONS of complaints against the devil, and I also have MILLIONS of decrees from the Lord Jesus Christ, the Lord of Hosts and the Holy Ghost that the devil MUST abide by. **This stand against the devil also gives me “standing” in the courts because the court of the Universe recognizes me whenever I file a complaint or a petition against that fool devil.** Again, **the devil’s retaliation was to try and kill me physically so I would SHUT UP and STOP filing complaints and petitions against him,** but I am too hard-headed to listen to what the devil says or does. I have stood against the devil’s “cases” in my experience, and since I have legal authorities given to

me by the Lord Jesus Christ PERSONALLY, the devil is limited in what he can do to me and my household. The good news is that I can go back retroactively to get my recompense from what the devil did to me when I was younger.

I bet you didn't know that.

I am sharing my struggle against the devil with all of you so that YOU will take the time to take what has been presented and use it to your advantage when you are dealing with these lockdowns and draconian procedures that our elected officials are putting upon all of us. **Remember – they have the LEGAL RIGHT to subjugate you because they get their marching orders from the devil that has much more authority that you do.** The conflict is when people who are disciples or followers of Christ rise up and go to their Lord and Saviour to get the requisite authority and LEGAL RIGHTS to tell that fool devil to sit down and shut the hell up. The devil CANNOT compete against the decrees and judgments that are handed down from the Lord Jesus Christ who is OUR advocate, as we can see in scripture here:

1 John 2:1-2 - My little children, these things write I unto you, that ye sin not. And if any man sin, we have an advocate with the Father, Jesus Christ the righteous: And he is the propitiation for our sins: and not for ours only, but also for the sins of the whole world.

It is my contention that the current church world is the culprit of keeping those who go to church bound and enslaved because they will NOT teach this. It will only be a remnant of TRUE disciples and followers of Christ who will be able to stand against the devil and prevail, using the courts of the Universe to do so. I explain about events here, and how to file complaints here, and how to file a petition here. Know that you can always ask for a hearing, and it will be the Lord of Hosts who will determine if He will hear your case or not.

Know that none of this is available to you if you are not a disciple or a follower of Christ who is filled with the Holy Ghost. That will disqualify 95% of the church world, as they are following church doctrine and NOT the Lord Jesus Christ as Calvinists, Dispensationalists and other types of “ists” the church world is peddling.

We are supposed to be learning about how to resist the devil as Jesus commanded us to, and now the devil feel he has dumbed down the church world enough so he can rule over the church world using FEAR. There are more scared people in the church than anywhere else in history, and they are expecting Jesus to do EVERYTHING while they sit there, like a bump on a log, doing NOTHING.

Jesus is not going to babysit you.

He is going to let the devil kick your teeth in so you will learn how to resist the devil as He commanded us to do, as he says in scripture here:

James 4:7 - Submit yourselves therefore to God. Resist the devil, and he will flee from you.

One way or another, you are going to confront the devil if you are a true disciple or Christ or a follower of Christ, and the devil is going to try and kill you too. My experience has hardened my resolve, and a person who is NOT afraid to die is a grave threat to the devil. If a person will do as Jesus asks of them not worrying about dying, that person is a potent weapon that Jesus can use to help those who are afraid to become bold and follow Jesus Christ. The devil HATES that type of person because he knows that he cannot control them, and he WILL run away in his high heel screaming like the bitch that he is.

Take the time to learn about the courts of the Universe knowing that Jesus is OUR advocate. You can quit being a victim and get YOUR standing in the courts of the Universe. You will know how to intercede for others which will help them when they are judged by Jesus and know your prayers are effective because you will be able to physically see the fruits of your prayers when you are using the courts of the Universe.
